It is understood that this authorization is given in advance of any specific diagnosis, treatment or hospital care being required but is given to provide authority and power to render care which the aforementioned physician in the exercise of his best judgment may deem advisable. It is understood that efforts shall be made to contact the under-signed parent or legal guardian prior to rendering treatment to the patient, but that any of the above treatment will not be withheld if the undersigned cannot be reached. This authorization is given pursuant to the provisions of Section 25.8 of the Civil Code of the State of California. The signing of this release only gives SRV-CASA, and agents thereof, the right to consent for treatment of minors. It does not release signee of liability from medical cost arising from said treatment. SRV-CASA does not assume liability of said cost and is not liable for any complications arising from said treatment.
